Our next meet is this Saturday, June 28, at Heatherfield. This will be a very close meet, and Jim is hoping that everyone will make an effort to attend. Swimmers should arrive at the meet by 7:30 a.m. for warm-ups. The Heatherfield pool is located in an apartment complex/condominium community in Lower Paxton Township, just off Route 22. To get there, take 22 West towards Harrisburg. Turn left (south) on Mountain Road and go past Karn's Grocery Store to the light at Jonestown Rd. Turn left on Jonestown Rd and proceed for approximately 0.5 miles. Turn right on Lopax Road and proceed for 0.5 miles. The pool is located on right side below the Community Building. Please park in lower lot, just past pool. Do NOT park in numbered spaces. (Parking may get competitive; we recommend carpools.)

Turn left onto Main St. At first light turn right onto North Hanover St. Follow North Hanover through light at RR underpass. Turn right on Kokomo Ave. approximately 100 meters beyond the underpass. Do not cross the Swatara Creek. Follow Kokomo to pool on right. ***We have not yet been assigned a warm-up time, but the meet begins at 5.***
